

## A. Teacher Tapp Event Services - Scope of Agreement

Welcome to Teacher Tapp! We know as event providers that you want your events to run safely and smoothly. We want the same thing for our platform. We're excited that you're here and supporting our teacher users! Please read these Terms of Service ("Terms") carefully because they contain important information about your legal rights, remedies, and obligations.

By accessing or using Teacher Tapp's Event Services, you are agreeing to the Scope of Agreement as set out in this Section A; and to <u>Section B</u>, which sets out our Standard Terms of Business. (You may also wish to review our <u>Privacy Policy</u> and make reference to our app user's <u>Terms and Conditions</u>). Do not access or use the Services if you do not agree to the terms and conditions of these Terms.

These Event Services Terms and Conditions ("Agreement") are entered into by and between Education Intelligence Limited trading as Teacher Tapp ("**Teacher Tapp**", "we" or "us") and the individual or entity ("**Event Provider**" or "you") uploading events to our platform. By uploading events to our app, you agree to be bound by the terms and conditions set forth below.

Here are some important definitions to help you navigate these Terms.

- 1. "Teachers" means Teacher Tapp App users who choose to use our Services to view information about events, save information about events on our App, and/or indicate their intention to attend an event.
- "Material" includes information, data, text, editorial content, design elements, look and feel, formatting, graphics, images, photographs, videos, music, sounds, and other content and materials.
- 3. "Event Provider" means an event provider using our Services to promote events to our users.
- 4. "Event Portal" refers to your event page to upload, edit and review your events.
- 5. "Your Content" is any Material that you contribute, provide, post, or make available using the Services, or that you otherwise contribute, provide, post or make available to us, or that you authorise us to use.

#### A - Scope of Agreement

# 1. Scope of Work

- 1.1 Teacher Tapp is a platform which allows us to ask questions and provide information to our subscribers (typically practising teachers in the United Kingdom) via a smartphone application ("Platform").
- 1.2 We offer an events advertisement and promotion platform that helps Event Providers advertise and connect through memorable live and on-demand experiences. Through our Services, Providers can create advertorial information about their online or in-person events or podcast shows. We are not the provider, organiser, or owner of the events listed on the Services nor are we the seller of tickets, registrations or any merchandise on the Services.
- 1.3 When hosting an event, the Event Provider is solely responsible for ensuring that their event and any page displaying an event complies with any applicable laws, rules, and regulations, and that the goods and services described on the event page are delivered as described and in an accurate, satisfactory manner.

### 2. Event Submission and Approval:

- 2.1 Event Provider agrees to submit accurate and complete information about the events they wish to promote on the Teacher Tapp app.
- 2.2 Company reserves the right to review, modify, or reject any event submission at its sole discretion.

#### 3. Event Content:

- 3.1 Event Provider is solely responsible for the accuracy, quality, and legality of the content provided for each event.
- 3.2 Event Providers must have the necessary rights and permissions for all content associated with their events, including but not limited to images, descriptions, and multimedia.

#### 4. Cancellation and Refunds:

- 4.1 Event Providers/ You must clearly communicate cancellation policies and refund conditions to teachers via their own webpages and/or communications.
- 4.2 Event Providers/ You are responsible for handling any refunds or disputes directly with teachers.
